Mr. Elder recognized guest Dave Hoobler who had comments about the additional abandoment on Hutchenson Road, both he and the Supervisors felt that this should be the final measure needed to finish the Steckler road abandonment. The Supervisors and Mr. Hoobler had an additional discussion about the boundries and the confusion as to who the rightful owners where to the property on each side of the abandonment. Mr. Hoobler he was happy to see that Sonntag Excavating received this years paving bid. That the interaction with them and his company has always been positive.

Roadmaster Report:

- Grader work has been started on Vernon and Zahnizer Road
- Grader has been down with broken oil lines and repairs have been made, the longevity of the Grader is very questionable. A decision on a replacement maybe needed very soon.

The Supervisors spoke about the 87' Ford Dump Truck and not having any real interest with PennDot advertizing the truck to other Municipalities, Gander **Motioned** to advertise the truck to accept sealed bids to be opened at next months regular June meeting Elder 2nd.

The Supervisors had asked members from Lakeview School Board and the Lakeview Girls Fast Pitch League to attend the meeting to discuss their interaction with LARA no one from either organizations came. The Supervisors had a discussion over their frustration with the progress at the Jack Jones Memorial Park and the lack of communication between LARA and the Township. The Supervisors asked to contact Solicitor Watson as to drafting a letter notifing LARA that the Township wants to resume control of running the park. What LARA has done was no small feet, however, the Supervisors are concerned with the upkeep of what is currently there, finishing the developement and getting the park used to its potential.

Supervisor Elder asked that DEP be contacted again about the use of brine for dust control, as our renewal permit has not yet come.
