The Lake Township regular meeting was held on Monday, February 11, 2019 at the Lake Township Municipal Building.

*Present were Supervisors Jon Gander, Fred Elder and Harry Fairlamb along with Secretary Deanna Yarnell.

*Chairman Elder opened the meeting at 8:00p.m. Minutes to the January Organization and regular meeting where read and approved by a **motion** from Gander, 2nd by Fairlamb.

Chairman Elder recognized guest Megan Alexander. The Alexander's are in the process of subdividing a parcel from Mrs. Alexander's mother located off of the Fredonia road. The parcel would be next to the township property that sits at the corner of Strausser and Fredonia Road. Mrs. Alexander was inquiring about the permit process and had several sewage questions. Mr. Elder had a discussion of the process and Secretary Yarnell gave them the Township SEO contact information. Mrs. Alexander inquired about a right of way through the Township property if their first choice of connection to the existing driveway of her mother's property was not feasible due to the location of the septic and home. The Supervisors would like them to pursue all other avenues of a driveway, as they are not wanting to do a right of way through the Township parcel, however if they need to revisit this at a later time they would consider it as a last option. Mr. David Parker representing Parker Logging asked about starting a logging project on Strausser Road that would have his trucks hauling about 15-20 truckloads of timber over the end of Strausser onto Stockfarm coming out onto Rt. 62. The Supervisors said that he could proceed provided that the job was completed prior to any Spring thaw. The Supervisors said that they would monitor the progress of the road surface, Mr. Parker agreed to work with the Supervisors on road conditions.

Roadmaster Report:

- The totals and resolution for the Delaware COG Tar and Chip program are due by March 8, 2019
- Still in search of a grader replacement for the Township current grader.
- Cooley Construction from Cambridge Springs has been contacted, as recommended by PennDot rep Jon Wilson, as to give estimates on resurfacing several roads that are deteriorating in the Township. Their method of tearing up and putting road surface back down to be tar and chipped over is something the Supervisors are wanting to compare to the costly black top needed to give a more permanent road surface on Township roads.

The Supervisors had a discussion on the road projects for Lake Township for 2019 a **motion** to pass Resolution 01-2019 joining the Delaware COG to participate in the Tar and Chip program was approved by a motion from Gander 2nd by Elder.
