The Lake Township regular meeting was held on Monday, March 11, 2019 at the Lake Township Municipal Building.

*Present were Supervisors Jon Gander, Fred Elder and Harry Fairlamb along with Secretary Deanna Yarnell.

*Chairman Elder opened the meeting at 8:00p.m. Minutes to the February regular meeting were read and approved by a **motion** from Elder, 2nd by Fairlamb.

Guests: Tori Welton and Wyatt Zebrovious

Bills were approved and paid

Treasurer Report:

- General Fund \$ 26,652.39
- General Savings \$ 85,959.13
- State Checking \$ 1,027.23
- State Savings \$ 110,070.57

Chairman Elder recognized guest Tori Welton. Ms. Welton representing Wagler LLC presented the Supervisors with a plan to tie into the Lakeview Area Sewage Authority. Ms. Welton said she attended the last sewage meeting and requested tie in service and that the sewage authority said that they would be willing to tie in but that it had to be between Lake Township and the Lakeview Area Sewage Authority. Ms. Welton wanted to know if the Supervisors would be willing to make this request on their behalf. After a discussion of tie in costs and benefits the Supervisors agreed to request tie in service for the Lake Township side of the Stoneboro Lake. Tie in service would be limited to the cottages on the lake no other residence would be tying into the system.

Wyatt Zebrovious had no comment

The following **Motions** were presented:

Jon Gander **Motioned** to close the State Fund Checking and State Fund Savings at Mercer County State Bank and to open one account with PLIGIT a State Fund Checking, Harry Fairlamb 2nd.

Harry Fairlamb **Motioned** to have Parker Logging remove trees on the Township Property directly behind the Township building, Jon Gander 2nd.

Harry Fairlamb **Motioned** to sign the resolution to put the question on the May ballot "Do you favor the issuance of licenses to conduct small games of chance in the Township of Lake?" Jon Gander 2nd. Resolution 02-2019 was signed and will be taken with the question to the court house to be put on the May ballot. Fred Elder would sign but NOT in favor.

Secretary Report:

- New 2019 Solicitor agreement was signed; the retainer was sent in previously.
- The Baseball back fence has been installed. Payment reimbursement from the county will be submitted. Continued discussion on moving the storage shed donated by Flex-O-Span was discussed. No information has been received from LARA to finish the last baseball field at the Complex. Mr. Barrish has said on numerous occasions that LARA had the information. Mr. Kraynak was to get the information to the Supervisors after their last meeting, due to the numerous delays the Supervisors will proceed with finishing the projects at the Complex without LARA.

- Still in search of a grader replacement for the Township current grader.
- Trees have been removed from various
