Motion by Elder 2nd by Gander to sign Resolution 01-2026 to join the 2026 Mercer County Joint Sealcoat bid program. To appoint Chairman Elder as the delegate and V. Chairman Harry Fairlamb as the alternate delegate.

Secretary Deanna Yarnell requested full-time status at the Township. Her outside commitments have been reduced, and she would like to work at the Township full-time starting in January 2026. This would include regular office hours at the Township as well as allowing her more time to devote to her Emergence Management position, training and Grant writing. The Supervisors discussed items that could be offered in addition to a pay increase such as health benefits and the possible open Tax Collector position if and when Barb Elder resigns. The Supervisors agreed to full time status and a pay increase to \$2000.00 Monthly by a Motion from Gander 2nd by Fairlamb. Secretary Yarnell asked to have the pay broke down to biweekly and they agreed. Secretary Yarnell has spoken to Tax Collector Barb Elder about becoming her Deputy pending Township approval and the possibility of taking on Tax Collector for the Township. There are issues with her being eligible for Tax Collector due to residency the Solicitor has been asked as there have been multiple answers from the County Tax Office and Board of Elections.

The Supervisors approved Deanna Yarnell to be Deputy Tax Collector for Barb Elder. There are no residency issues with being Deputy Tax Collector.
