Secretary Report:

Pennsylvania Group Trust is not an option for insurance for Lake Township. They rates are very high.

Clean-up Day will be put on hold as the Supervisors are not sure that there is a need in the Township. As well as the cost of roll-offs and an employee to oversee the event may outweigh any benefit.

The cost for upgraded Quickbooks and payroll service is over \$2100.00 per year. This is considerably more than was previously spent. Our outdated QB 2019 with manual payroll service is still operational. Secretary Yarnell is looking into just a payroll service however, they are very costly as well. She will use the manual version this year to see how it goes and decide in the fall if a paid service is needed. Saving the Township considerably.

Secretary Yarnell contacted the Mercer County Regional Planning Commission about grant writing. In her conversation the Multimodal grant for Canon/Billy Boyd Road through DCED was brought up. Their representative was going to reach out to PennDOT to see why they did not support the project and help with the next submission.

Bills were approved and paid.
