**TOWNSHIP OF LAKE

ORDINANCE NO. 1-2018**

AN ORDINANCE OF THE TOWNSHIP OF LAKE, MERCER COUNTY PENNSYLVANIA, VACATING A CERTAIN STREET IN THE TOWNSHIP OF LAKE ALONG THE PROPERTIES OF HOOBLER, SLATER, AND H&H MATERIALS.

WHEREAS, On \_\_\_\_\_, 2018, after a proper hearing and with due notice, the Board of Supervisors of Lake Township, Mercer County, Pennsylvania, authorized the closing of a portion of Hutcheson Road, in the Township;

WHEREAS, the Township has taken various steps to formally vacate the below described portion of Hutcheson Road, including action by Supervisors following public meetings;

WHEREAS, an Ordinance is required to close said street;

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Lake Township, Mercer County, Pennsylvania, and it is hereby Ordained and Enacted by and with the authority of the same as follows:

SECTION 1. The portion of Hutcheson Road to be closed is described as follows:

Beginning at a point being the intersection of Steckler Road and Hutcheson Road;  
Thence North 75° 32' 41" West along the centerline of said Hutcheson Road a distance of 251 feet to a point.

SECTION 2. This Ordinance is enacted pursuant to Section 2305 of the Township Code, as amended, 53 Pa.C.S.A. 67305, and shall become effective thirty (30) days after the enactment thereof.

NOW THEREFORE BE IT RESOLVED that the above described land is hereby vested as to all public right and VACATED as to all public right and interest in said street; PROVIDED, HOWEVER, the Township of Lake reserves any easements it may have or could have over, under and across said vacated street for the purposes of maintenance, installation, renovation, replacement and/or construction of any required additions, of the Township sanitary and storm sewer line(s); and further, provided the street shall be split equally by the adjoining land owners as their interests appear according to the applicable laws.
